On 15 April 2020, the Commission, in cooperation with the European Council, presented a roadmap showing a path towards the gradual lifting of the containment measures. This roadmap recommends, in particular, harmonised data gathering, increasing the resilience of healthcare systems and an increase in testing capacity.

ECDC: Surveillance of COVID-19 at long-term care facilities in the EU/EEA

In this document, published on 19 May 2020, the European Centre for Disease Prevention and Control (ECDC) finds that it is of paramount importance to be able to rapidly identify, assess and control COVID-19 outbreaks in LTCFs. This document provides guidance for Member States planning to implement surveillance systems.

On 8 April 2020, the ECDC published a report containing guidance on the discharge of hospital patients at an early stage of improvement, particularly in order to maintain healthcare capacity for seriously ill patients.

In a report dated 8 April 2020, the ECDC estimates that there is a high risk of exceeding the capacity of health and social care systems in the EU/EEA and the United Kingdom, and calls for a stepping-up of measures to help cope with the flow of COVID-19 patients.

On 20 March 2020, the ECDC published a document evaluating the risks and management options for the safe and sustainable supply of substances of human origin in the context of the pandemic.

The aim of this project is to provide technical assistance to the ERNs. Given the different approaches within the ERNs to clinical guidelines, it was deemed necessary to develop a common methodology, particularly in order to better define the specificity of the ERNs in this area.

ERN: Feasibility study on the opportunity of setting up a European Expert Network for rare communicable diseases and other rare pathologies

This study, published on 28 February 2020, concludes that, since all identified rare non-communicable diseases linked to mobility and globalisation are already covered by various existing ERNs, there is no need to create a new specific network for them. The study therefore focused on rare communicable diseases linked to mobility and globalisation and considered three scenarios.

European Council: cooperation between the Member States in the fight against COVID-19 On 10 March 2020, the EU Heads of State agreed to step up coordination in order, notably, to limit the spread of the virus, to provide medical equipment and to promote research.

This document, published on 30 March 2020, recommends that all Member States carefully review their national strategies in the light of these recommendations in order to take measures to reduce the pressure on their respective health systems.

On 26 March 2020, the Member States called on the Commission to pursue and accelerate its efforts to help ensure urgent and adequate provision of medical equipment throughout the EU. The resolution, adopted on 17 April 2020, calls particularly for the Union to be given extended competences to act in the case of cross-border health threats, to ensure a coordinated response, and to propose a health autonomy action to strengthen European autonomy in strategic areas such as active pharmaceutical ingredients.

In this document published on 18 March 2020, the Commission emphasises that testing strategies must adapt to ensure an optimal use of resources and to reduce the pressure on laboratories.

In early April 2020, the ENVI committee wrote to the Council and to the Member States, calling for a strengthening of the ECDC and the use of the EU coordination mechanisms to ensure that the countries which still have material and human capacities put them at the service of those at risk of being overwhelmed by the pandemic.

In a communication, published on 3 April 2020, the Commission invites the national, regional and local health authorities to fully operate the existing structures and mechanisms to step up cooperation between the Member States, and to maximise the human and material capacity of EU health systems.

An article published in Euractiv on 31 March 2020 reports that the Austrian health system is heavily dependent on staff from Eastern Europe, many of whom shuttle back and forth, staying in Austria for several weeks.

Council of the EU: debate on the EU's strategic autonomy in critical industrial sectors

On 15 May 2020, the EU ministers responsible for industry highlighted the need to guarantee the EU's strategic autonomy by reducing its dependency on third countries for critical supplies such as pharmaceutical ingredients and raw materials. However, the Member States still do not agree on the political instruments to be used to this end.

European Commission: approval of the merger of Mylan and Pfizer's Upjohn division, subject to conditions

This merger, authorised by the Commission on 22 April 2020, will lead to the combination of Mylan, one of the top five generic suppliers in the EEA, and the medicines manufacturer Upjohn.

This 23 million euro State aid scheme, approved on 3 April 2020, will enable service providers to purchase, lease, licence and implement e-health applications.

The Portuguese competition authority published a press release on 19 March 2020 reporting that the hospital had been fined 155,000 euros for acquiring sole control of Hospital de S. Gonçalo de Lagos S.A. (HSGL) without obtaining approval from the antitrust entity.

The UK competition authority, in a press release dated 25 March 2020, states that, if cooperation takes place purely to ensure the supply of essential goods, it will take no action against it.

On 25 March 2020, the Commission opened an investigation, to determine whether this acquisition restricts competition and innovation for the supply of dual haemostatic patches.

Judgment: the CJEU finds implementing regulation 2016/1140, concerning the classification of certain goods in the Combined Nomenclature, invalid

This case is the result of a dispute between Pfizer Consumer Healthcare Ltd and the British tax authorities. The Court of Justice of the European Union (CJEU) found, in case C-182/19, that the Commission's implementing regulation (EU) 2016/1140, on the classification of certain goods in the Combined Nomenclature, is invalid.

Judgment: health telephone services can be exempted from VAT

In case C-48/19, the CJEU found that medical services provided by telephone may be exempt from VAT, as long as they pursue a therapeutic objective. Moreover, the nurses and medical assistants providing this service do not require additional professional qualifications to be VAT-exempt.

Judgment: a private hospital can be eligible for VAT exemption

The judgment in case C-211/18 concerns VAT exemption for care provided by a private hospital. According to the judgment, the competent authorities of a Member State may take into account the fact that care provided by the hospital is supplied under contracts concluded with the public authorities, at prices fixed by those contracts, and that the costs are partially borne by the social security institutions.

Judgment: A product developed after the filing date of an application for a basic patent is not protected by that patent

This judgment follows proceedings between Royalty Pharma and the German Patent and Trade Mark Office concerning the Office's refusal to issue a supplementary protection certificate for sitagliptin, a treatment for diabetes mellitus. In case C-650/17, the CJEU found that a product is not protected by a basic patent in force if it was developed after the filing date of the application for the basic patent, following an independent inventive step.

Judgment: the package leaflet referred to in directive 2004/27/EC must only contain the information listed therein

This judgment refers to two disputes between the German Homeopathy Union (DHU) and the Republic of Germany, concerning a refusal to register homeopathic medicinal products the package leaflet of which included information related to posology. In joined cases C-101/19 and C-102/19, the CJEU found that, under European law, the package leaflet should not contain any information other than that listed in directive 2004/27/EC.

Judgment: rehabilitation allowances are subject to the regulation on coordination of social security systems

In case C-135/19, the CJEU found that rehabilitation allowances are sickness benefits, and are therefore covered by regulation 465/2012 on coordination of social security systems. A person who moves his/her place of residence to another Member State may therefore be refused such a benefit by the competent institution of his/her Member State of origin, since that person is now subject to the legislation of the Member State in which his/her place of residence is situated.
