## Council: Progress report on strengthening the role of the ECDC

The regulatory package for the European Health Union presented by the European Commission on 11 November 2020 includes a proposal for a stronger mandate for the European Centre for Disease Prevention and Control (ECDC). The proposal foresees that the ECDC can better assist Member States and the European Commission with real-time monitoring of the epidemiological situation or with mobilising EU health task forces. Ministers were briefed on the progress of the talks at the meeting of the Council of the European Union (EU).

Stakeholders are invited to exchange views on how the Directive has improved patients' rights in respect of healthcare abroad and on its role in strengthening European cooperation in the field of rare and complex diseases.

## EC: Report on the application of the Directive on patients' rights in cross-border

Directive 2011/24/EU provides that when a European patient is treated in another Member State, the costs of healthcare may be reimbursed by the country of affiliation up to the level provided for by the healthcare system of that country. The latest report on the application of the Directive, with data from Member States on cross-border healthcare for the year 2019, reveals that medical tourism remains a limited phenomenon, mostly taking place between neighbouring countries. Twenty Member States and Iceland have introduced a system of prior authorisation for certain types of healthcare.

## 2 Medicines and medical devices

#### EP and Council: Political deal on health technology assessment (HTA)

The Council of the EU and the European Parliament have struck a political deal on a joint European framework for health technology assessment (HTA). The proposal harmonises the requirements for this procedure, which compares new medical interventions with existing ones or with the status quo. Under the agreed scheme, Member States must take due account of the published joint clinical reports at EU level, but are not obliged to use these joint reports at national level.

## Council: Agreement on reinforcing the role of the European Medicines Agency (EMA)

Health ministers in the Council of the EU have reached agreement on the general approach relating to the proposal for a regulation to reinforce the role of the European Medicines Agency (EMA). In particular, the intention is to reduce shortages of medicines and medical products, to ensure timely development of high-quality and efficacious medicines and to strengthen crisis preparedness and management in the field of medicines and medical devices. The draft is part of the broader regulatory package for a European Health Union.

#### EP: Position on extending the mandate of the EMA

The Parliament has adopted its position for negotiations with the Council on extending the mandate of the EMA and strengthening its role. To enhance the agency's powers in crisis preparedness, management for medicinal products and medical devices, MEPs are calling for the creation of an interoperable digital EU database aimed at detecting, predicting and preventing shortages of medicinal products.

## EC: Structured dialogue on security of medicines supply

The structured dialogue initiative facilitates discussions with and between the actors in the pharmaceutical manufacturing value chain, public authorities, research community, health professionals and patient organisations. It is a two-phase process. The objective of phase 1 is to gain a better understanding of the functioning of global pharmaceutical supply chains and to identify the precise causes of different potential vulnerabilities. Phase 2 will result in concrete measures that will address the identified issues.

#### AIM: Tool for calculating fair medicines prices in Europe

The International Association of Mutual Benefit Societies (AIM) has developed a tool for calculating fair medicines prices in Europe. The calculator transposes the fair pricing model developed previously by AIM into a policy tool that should help the public, specialists and non-

specialists alike, to evaluate fair medicines prices and compare them with those currently paid by healthcare systems.

## EP: Resolution on the trade-related aspects and implications of the COVID-19 outbreak

This European Parliament resolution focuses, among other things, on lessons learnt from the COVID-19 crisis for trade policy for critical health products. The resolution calls for greater transparency in respect of available stocks, global supply networks, production capacities and the pricing of essential health products, the implementation and development of exceptions for public health security in the intellectual property rights framework and an increase in the global mobility of essential services.

# EC: Proposal for a regulatory framework for artificial intelligence (AI) and a new coordinated plan by the Union and the Member States

The Commission has presented new rules and actions for trustworthy artificial intelligence (AI). The proposal distinguishes between AI applications with an unacceptable risk, a high risk, a limited risk and a minimal risk. The plan calls for funding through the various European programmes. The plan focuses, among other things, on the contribution of AI to healthcare by expanding the cross-border exchange of information.

#### EC: Digital transformation of Europe by 2030

The Commission has presented a vision, targets and avenues for a successful digital transformation of Europe by 2030. The communication proposes to agree on a set of digital principles, to launch projects and to prepare a legislative proposal setting out a robust governance framework to monitor progress. The Commission is proposing a Digital Compass to translate the EU's digital ambitions for 2030 into concrete terms. One of the ambitions is for all citizens to have access to their e-medical records.

## Regulation establishing the Digital Europe Programme published

The Regulation establishing the Digital Europe Programme has been published in the Official Journal of the European Union. The general objectives of the programme are to support and accelerate the digital transformation of the economy, industry and society in the EU. Applications in healthcare are one of the spearheads of the programme. The financial envelope for the implementation of the programme for the 2021-2027 period is EUR 7.5 billion.

## TEHDAS project: Health data need dedicated EU regulation

The TEHDAS project is being implemented by 25 European countries with the involvement of various partners and stakeholders from all over Europe.

According to a TEHDAS analysis, the unique specificities of health data require dedicated EU legislation to regulate their cross-border use and exchange. The first TEHDAS output examines why regulating the secondary use of health data is a specific case in data governance that cannot be regulated only by horizontal legislation, such as the proposed Data Governance Act.

# EC: EU Strategy on the Rights of the Child and proposal for a Council Recommendation establishing a European Child Guarantee

The proposal for a Council Recommendation establishing a European Child Guarantee aims to promote equal opportunities for children at risk of poverty or social exclusion.

## EC: Study on the economic implementing framework of a possible EU Child Guarantee Scheme, including its financial foundation

The Commission has published a study on the economic implementing framework of a possible EU Child Guarantee Scheme, including its financial foundation, as well as a summary of this report. The study, which was coordinated by LISER and Applica, also includes an evaluation of the feasibility of providing routine health examinations and follow-up treatments free of charge.

## EP: Resolution on the European Child Guarantee adopted

The Resolution stresses that Member States should mainstream the European Child Guarantee across all policy sectors, allocate at least 5% of the ESF+ resources under shared management to supporting activities under the scheme, consider making the scheme a permanent instrument to prevent and tackle child poverty in a structural manner, and examine the possibility of establishing a European Authority for Children to support the implementation of the recommendation by Member States.

### Council: Recommendation for a European Child Guarantee adopted

The Council of the EU has adopted the recommendation establishing a European Child Guarantee. In particular, it is recommended that Member States guarantee effective and free access to early childhood education, school education, at least one healthy meal each school day, healthcare, healthy nutrition and adequate housing. Each Member State must nominate a national Child Guarantee coordinator who will submit an action plan to the Commission for the implementation of this recommendation.

## EP and Council: Green light for ESF+

The EP and the Council of the EU have approved the European Social Fund Plus (ESF+) Regulation, worth EUR 99.3 billion. Countries where children's risk of poverty or social exclusion is above the EU average must use at least 5% of their ESF+ resources to tackle this issue.

#### Porto Social Summit

EU leaders, European institutions, social partners and civil society representatives met in Porto to reinforce their commitment to the implementation of the European Pillar of Social Rights. They discussed the European social policy agenda for the next decade and how to tackle existing and future challenges. There were 3 main themes, including the welfare state and social protection. At the end of the conference, the Porto Social Commitment was co-signed.

# Council: Assessment of the implementation of the 2020 and 2019 country-specific recommendations approved

The country-specific recommendations are provided in the context of the European Semester, the EU's framework for economic policy coordination in the European Union. The Council of the EU has approved the assessment of the implementation of the country-specific recommendations in the social sector for 2020 and 2019. Healthcare reforms were part of the recommendations for most EU Member States.

## Council: Opinion on the revision of the Social Scoreboard

The Council of the EU has adopted an opinion for a revised Social Scoreboard, with new headline indicators. This Scoreboard is used as an evaluation tool within the framework of the European Semester. Discussions on proposed new secondary indicators relating to the health sector, including health and long-term care expenditure as a share of GDP, coverage of long-term care needs, and preventable and treatable mortality have been paused for now.

The aim is to enable digital verification of citizens' social security coverage and entitlements by competent actors and institutions across borders. In 2023, the evaluation could also cover the integration and digitalisation of the European Health Insurance Card.

According to the Council, women are disproportionately affected by the COVID-19 pandemic and the containment measures. For example, they are at greater risk of contracting COVID-19 because they are over-represented among healthcare workers. The Member States and the Commission are invited to take steps to mitigate the long-term disadvantages experienced by women as a result of the COVID-19 crisis and to make gender equality a driver for recovery.

## EC: European Semester Spring Package

This package contains the fiscal guidance for Member States. The European Semester will from now on be linked to the Member States' recovery and resilience plans, which set out the investments and reforms that the Recovery and Resilience Facility will finance. The Commission has also announced that the general escape clause of the Stability and Growth Pact will continue to be applied in 2022 and that no action will be taken regarding Member States with excessive budget deficits.

These guidelines provide that timely and equal access to affordable long-term care and healthcare services, including prevention and healthcare promotion, is particularly relevant in light of the COVID-19 crisis and in a context of ageing societies.

## European Court of Auditors: EU funding for cross-border regions needs better focus

The European Territorial Cooperation (Interreg) programme is aimed at encouraging economic growth in border areas. According to a report from the European Court of Auditors (ECA), the cooperation programmes financed through Interreg contain clear strategies for tackling cross-border challenges, but there are several weaknesses in the implementation and monitoring of the programmes. The report finds that some of the challenges, for example in the field of cross-border healthcare, should be addressed at national level, by the Member States.

## Euractiv: The European Court of Auditors is looking into the contracts with large auditing firms to provide technical assistance to Member States for structural reforms

According to Euractiv, the European Court of Auditors is examining contracts worth hundreds of millions that the European Commission has concluded with external consultants. Since the start of the Commission's Structural Reform Support Programme, the funds spent on the big auditing firms to provide technical assistance to Member States for reforms in the fields of justice, health and the labour market have risen sharply.

## Euractiv: Big consultants advise on structural reforms in the Member States

According to Euractiv, the European Commission spent over EUR 462 million on contracts with PWC, KPMG, Deloitte and EY between 2016 and 2019. The role of consultants in EU and Member State policy-making is increasing through the technical advice they provide for structural reforms, funded by the Commission through the Structural Reform Support Programme. In a letter, MEPs from across the political divide have questioned the involvement of these consultants in the Structural Reform Support Programme, in particular in sensitive areas covered by projects financed, including healthcare.

The Commission is allocating additional cohesion policy funding as part of a modification of the Operational Programmes (OPs) for funding from the European structural funds, within the framework of the Recovery Assistance for Cohesion and the Territories of Europe (REACT-EU) initiative. In several Member States, the additional resources will be used in particular for healthcare and long-term care.

## EC: Green light for the acquisition of GrandVision by EssilorLuxottica, subject to conditions

The Commission has approved the proposed acquisition of GrandVision by EssilorLuxottica. This approval has been granted subject to full compliance by EssilorLuxottica with the commitments it has made in this regard. EssilorLuxottica is the largest supplier of ophthalmic lenses and eyewear, both worldwide and in Europe. In addition, EssilorLuxottica is active in the retail sale of optical products. GrandVision is a globally active eyewear retailer and operates some of the largest optical chains throughout Europe.

The European Commission has fined Sigma-Aldrich EUR 7.5 million for providing incorrect or misleading information during the Commission's investigation into Merck's acquisition of Sigma-Aldrich.

This investigation is separate from the Commission's in-depth investigation into the substance of the case.

## 8 Infringement proceedings

Czech Republic: Failure to comply with EU rules on professional qualifications

The Commission is referring the Czech Republic to the Court of Justice of the European Union for non-compliance with EU rules on professional qualifications (Directive 2005/36/EC). The identified breaches concern various sector-specific issues affecting doctors, nurses, pharmacists, veterinary surgeons and architects, in addition to procedural formalities and guarantees for professionals.

Belgium: Independence of the Data Protection Authority

The Commission is opening an infringement procedure against Belgium on the independence of its Data Protection Authority. According to the Commission, Belgium is violating the provisions of the General Data Protection Regulation (GDPR) (Regulation (EU) 2016/679) because some members of the authority report to a management committee that is dependent on the Belgian government, participate in governmental COVID-19 contact tracing projects or are members of the Information Security Committee.

## 9 Court of Justice of the European Union

Judgment: Economically inactive EU citizens residing in another Member State have the right to be affiliated to the public sickness insurance system of the host Member State. In its judgment in Case C-535/19, the Court confirmed the right of economically inactive Union citizens residing in a Member State other than their Member State of origin to be affiliated to the public sickness insurance system of the host Member State in order to benefit from healthcare services financed by that State. Though the Court stated that EU law does not impose an obligation to affiliate such inactive citizens to that system free of charge. However, the required contribution must not be 'disproportionate'.

Judgment: Stand-by time during which the employee must be permanently available is working time under certain conditions

In its judgment in Cases C-344/19 (D.J. v Radiotelevizija Slovenija) and C-580/19 (RJ v Stadt Offenbach am Main), the Court stated that a period of stand-by time during which the employee must be permanently available can only be regarded, in its entirety, as working time if the obligations imposed on the worker significantly affect his or her ability to manage his or her free time during that period. The organisational difficulties that a period of stand-by time may entail for the worker and which are the result of natural factors or the free choice of that worker are not relevant.

In Case T-223/18, the General Court upheld the conclusions of the European Commission in the 2017 decision that the Italian healthcare system (SSN) was not economic in nature and therefore the public support to public hospitals operating under the SSN did not constitute State aid within the meaning of EU law.

Judgments: Appeals dismissed against fines imposed on manufacturers of medicines for delaying the marketing of a generic medicine

In its judgments in Cases C-586/16 P, C-588/16 P, C-591/16 P, C-601/16 P, C-611/16 and C-614/16 P, the Court of Justice dismissed appeals brought by a number of manufacturers of medicines involved in an agreement seeking to delay the marketing of the generic antidepressant citalopram. The European Commission had imposed on them fines of almost EUR 150 million.

Judgment: Conditions governing the marketing of a medicinal product not subject to medical prescription in a Member State

In its judgment in Case C-178/20 (Pharma Expressz), the Court stated that a medicinal product that is not subject to medical prescription in one Member State cannot be placed on the market in another Member State unless it has also been granted marketing authorisation in that Member State. In the absence of such authorisation, it may nevertheless be possible to supply that medicinal product where its use meets special medical needs, in accordance with EU law.
